#### Difference between "Individual ID" and "Site License Individual ID"

Eligibility	Anyone can apply.	Only members (teaching staff, students, etc.; excludes visitors) of an institution having an Institutional fixed-price service contract can apply. Application must be made from a terminal on the network of the institution you are affiliated with.

Cost for full text usage	Costs for accessing full texts with "fixed-price OK" and "fee- based" provision conditions are calculated on a per-paper basis. Please access the CiNii top page (http://ci.nii.ac.jp/) from a terminal within the institution you belong to. If the institution has a fixed-price service contract, the name of the institution will be displayed on the top right of the screen.

If there is no institution name displayed on the screen, that institution does not have a fixed-price service contract.
